# HOW TO ACHIEVE THESE OBJECTIVES?



Declare a public health emergency at European level without waiting for the emergency to become global and be declared by WHO



Assess and strengthen European and national preparedness and response planning for health threats through stress tests in Member States, in particular to determine the status of medical products reserves and the availability of intensive care units, as well as to map the production sites at national level



Provide health crisis response training for health professionals, particularly in cross-border regions



Anticipate the impact of a health threat on other diseases or conditions and ensure continuity of health care



# HOW TO ACHIEVE THESE OBJECTIVES?



Integrate prevention and health education into all European and national anticipation policies



Strengthen epidemiological surveillance through an enhanced European system for infectious diseases and other health threats



Ask the relevant European agencies to carry out a health risk assessment according to the origin of the crisis



Increase the role of the European Parliament in health governance (observer seat at the Health Security Committee and HERA - Health Emergency Preparedness and Response Authority - bodies)



Better define the rules for joint procurement of medicines and medical equipment and ensure more transparency vis-à-vis the European Parliament and European citizens in the drawing up of contracts



# HOW TO ACHIEVE THESE OBJECTIVES?



Establish an Advisory Committee to assist the Commission and Member States in decision-making



Empower the new health authority HERA to identify and respond to health threats, in coordination with other bodies



Ensure consultation with all stakeholders in the decision-making process for anticipating and responding to health crises, including in the governance of HERA



Implement this regulation by adopting the "Health in All Policies" and "One Health" approaches



Strengthen global cooperation through the negotiations of an international treaty on pandemics
